### Location

The Chelworth Industrial Estate is situated immediately to the west of Cricklade and the A419 dual carriageway. It's accessed from the B4553 and provides fast and easy access to Swindon and junction 15 of the M4 to the south (12 miles) as well as Cirencester (7 miles) and the M5 to the north at Gloucester (24 miles).

From early 2027, the A417 Missing Link dual carriageway works between Brockworth and Cowley will be completed, greatly improving drive times between the M4 and M5 motorways.

### Description

Warehouse Two is a high quality, purpose built logistics facility constructed in 2020. It benefits from 4 dock level loading doors, 1 surface level loading door and a 10m eaves height. Internally, there are two storey, air conditioned offices with a 500kg passenger lift and kitchen and staff facilities.

Externally, there is a concrete loading yard as well as extensive parking and external storage areas. The site is fenced and gated.

The existing racking can be left in situ if required.
