
The property is situated on the main route through Lostock Hall, Watkin Lane (B5254) adjacent to the Library, with other retail users opposite.

Tenancy

The property is let to Co-operative Group Food Limited with a guarantee from Tesco Stores Ltd on a Full Repairing and Insuring lease for a term of 20 years from 20 March 2015 expiring on 19 March 2035.

The passing rent is £75,113 per annum. The lease benefits from five yearly upward only rent reviews calculated in line with the All Items Retail Prices Index (RPI), compounded annually, with a collar and cap of 1% and 4%, respectively. The tenant had a break option with effect from 20 March 2025 which they didn't serve showing their commitment to the store and location.

The next rent review is on the 20 March 2030. The average RPI figure between June 2020 and May 2025 is 5.3%. Based on an assumed annual RPI growth of 3% compounded the rent would increase to in the region of £87,000 per annum which would show a reversionary yield of circa 7%.

Co-operative Group Food Limited (Company Number: 26715R) is a wholly owned subsidiary of The Co-operative Group Limited which is owned by over 4 million UK consumers.

The Co-op runs 2,600 food stores and more than 800 funeral homes, while also supplying products to over 5,100 additional outlets, including those operated by independent co-operative societies — through its wholesale division, Nisa Retail Limited. With a workforce of over 63,000, the Co-op generates an annual turnover of £11.5bn.
