DESCRIPTION

Units 3 & 3b Holder Road are currently interconnecting units which can be taken as a whole, or separate units.

Unit 3 extends to approx. 5,810 sq ft of industrial / warehouse space, which includes front offices of 980 sq ft, and a substantial mezzanine floor across the rear of the building of 2,525 sq ft, which is currently laid out as warehousing space.

This unit has the benefit of a side loading door, and is presented in good internal condition with heating, lighting etc. This unit has the benefit of a private parking area to the front of the building, with additional side parking to the entrance road.

Unit 3b is located at the rear, having a ground floor area of 1,865 sq ft, with a substantial mezzanine floor of 1,700 sq ft, together with the benefit of a roller shutter loading door and private entrance at the rear, with allocated yard / parking area, within a secure gated area.


