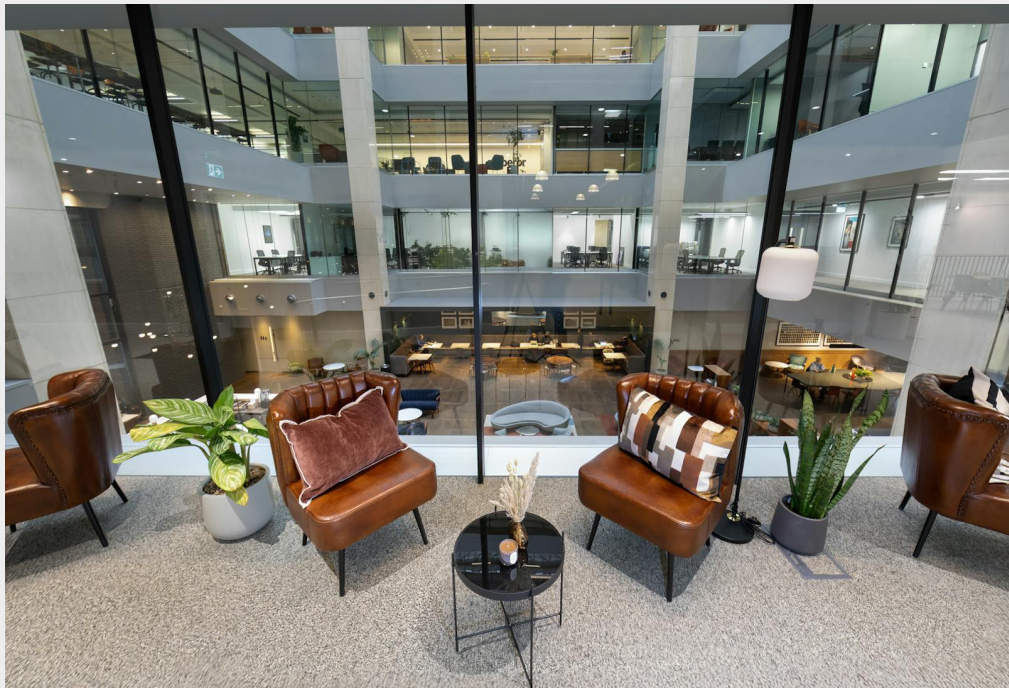


Description
