Description

The redevelopment of the Former Police Station provides three new ground floor retail units as part of the wider development providing 30 new residential units above.

Location

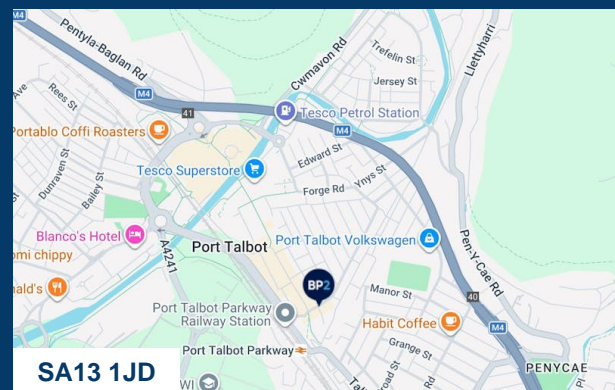
