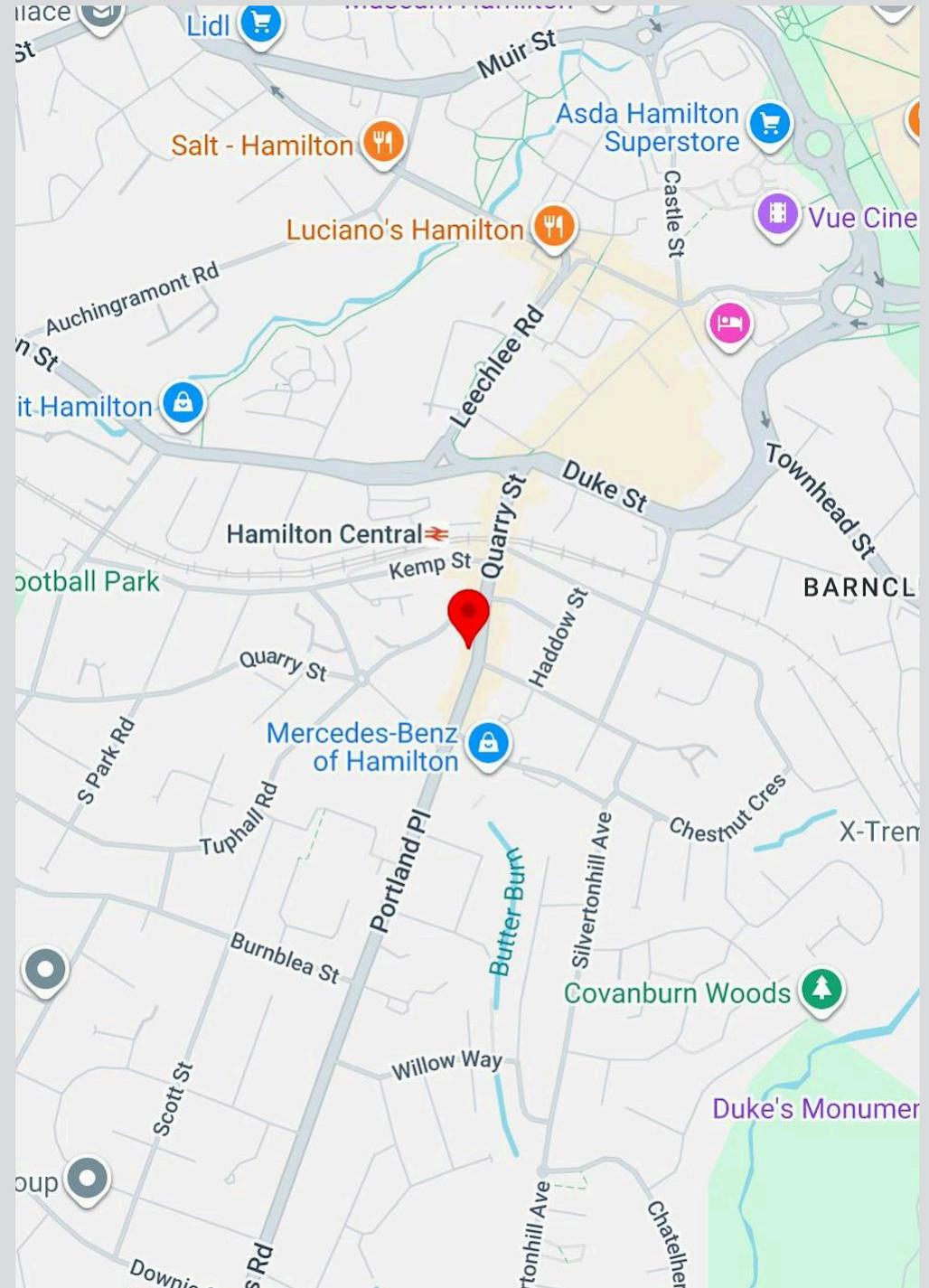
# Property Details

## LOCATION

Gateside Street is situated on one of the principal arterial routes surrounding Hamilton town centre, benefiting from excellent accessibility. The property occupies a prominent position on the west side of Gateside Street, adjacent to its junction with Quarry Street.

Hamilton, the administrative centre of South Lanarkshire, has a population of over 55,000 and lies approximately 12 miles south-east of Glasgow and 5 miles east of East Kilbride. The town is well-served by public transport, with two railway stations nearby, including Hamilton Central, which is only a short walk from the property.

The surrounding area accommodates a mix of national and local retailers and food outlets, including Pizza Hut Delivery, a local barbers, and Laurie Ross Insurance, among others.

## DESCRIPTION

12 Gateside Street comprises a ground-floor retail unit within a three-storey sandstone tenement building. The upper floors are predominantly residential.

Internally, the property offers a large open-plan sales area leading to multiple treatment rooms, storage space, staff facilities, and rear access. The flexible layout is suitable for a variety of retail or commercial uses, subject to consent.

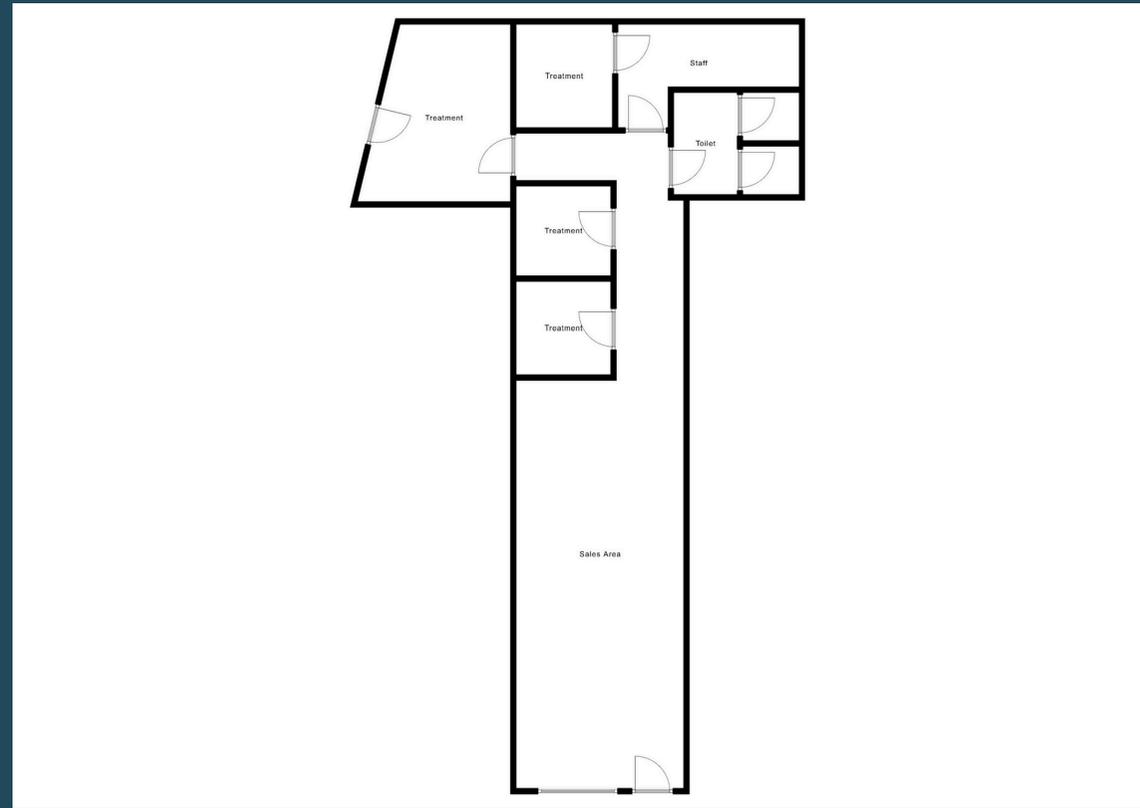
