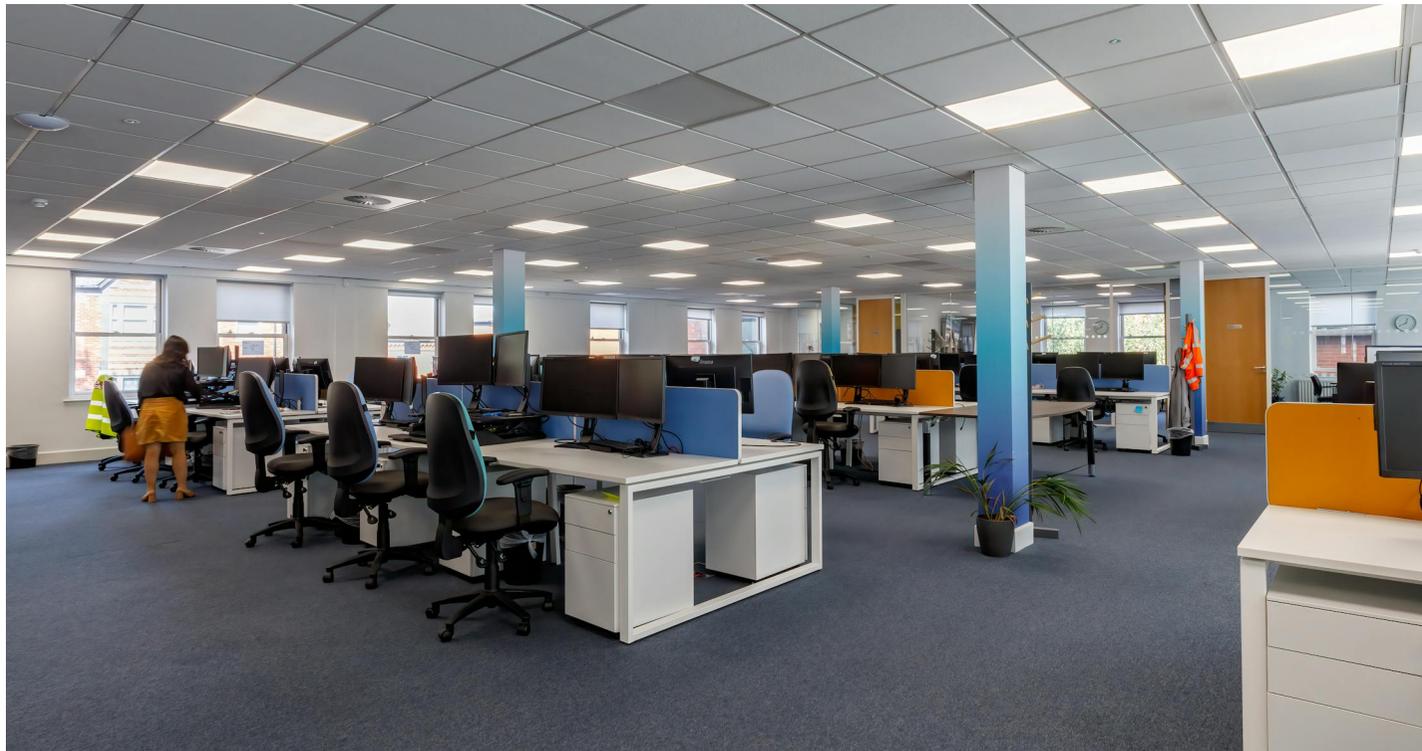

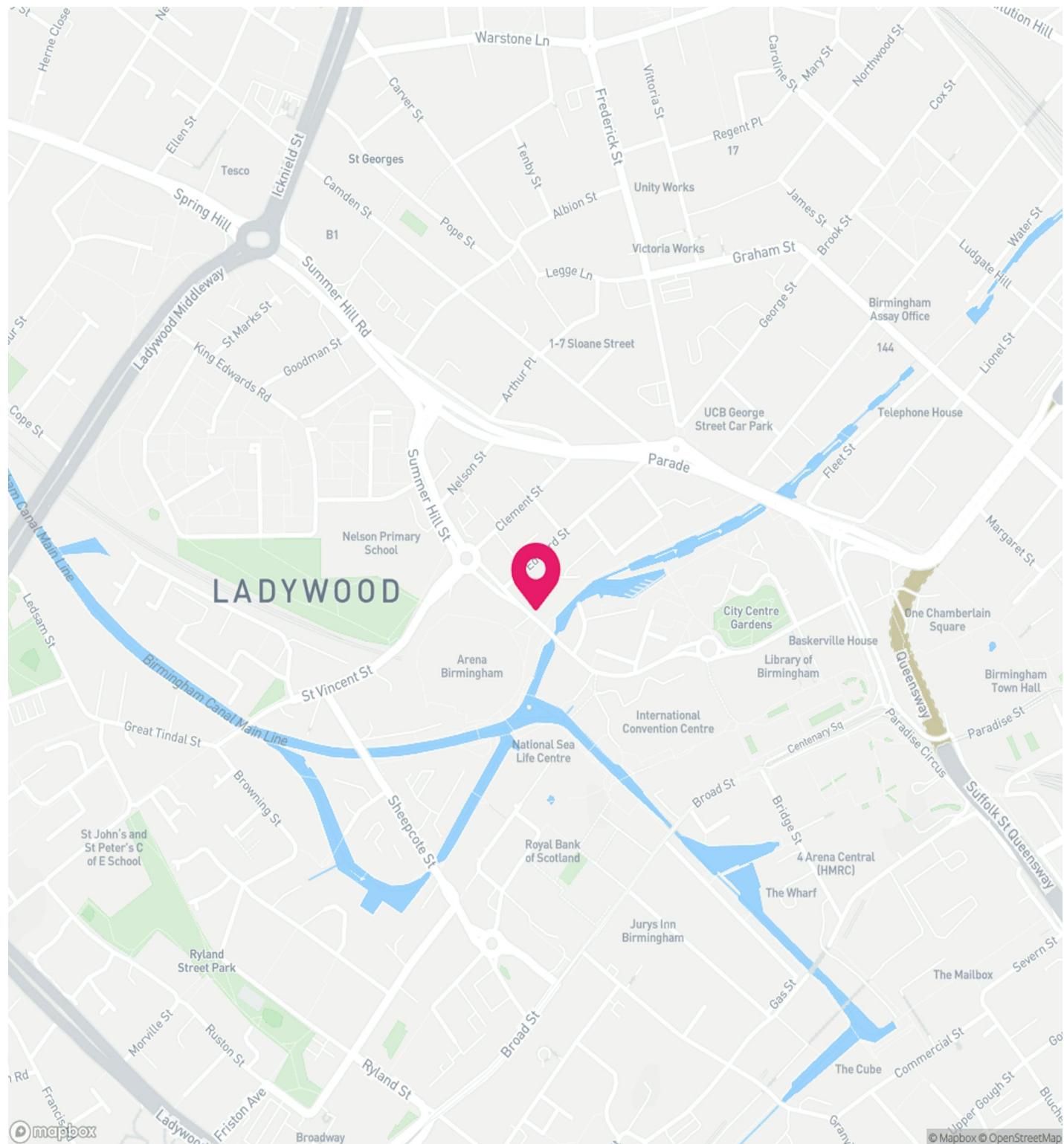


LOCATION
