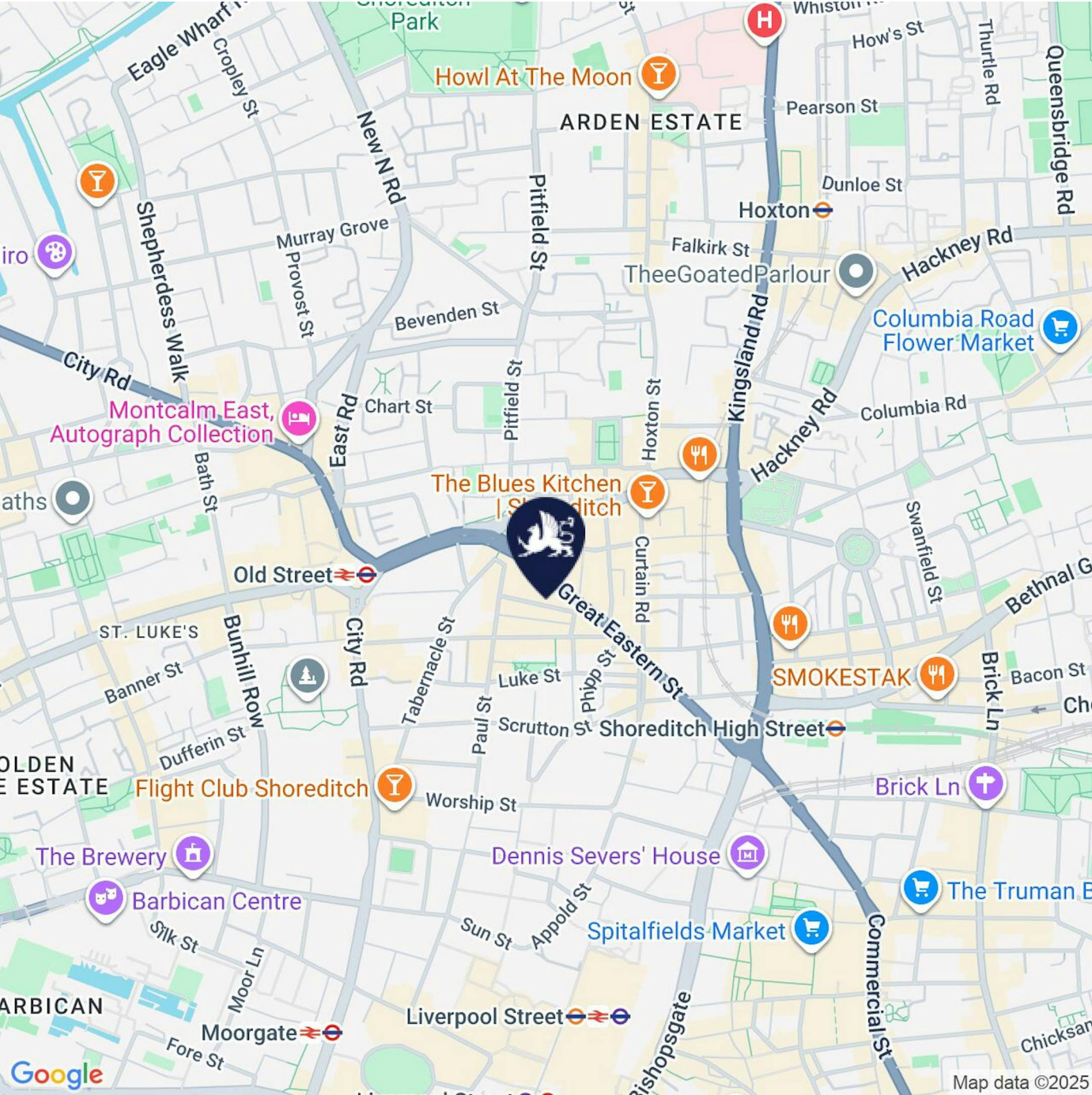


Location
