## DESCRIPTION

Resorts World is a mixed-use scheme which opened in 2015 and sits next to the Resorts World Arena (c.17,000 capacity and c.100 events per year) and the NEC Conference Centre which hosts over 500 events/shows per year.

The scheme benefits from excellent transport links easily accessed from the Junction 6 of the M43 and a short distance from Birmingham International Railway Station and Birmingham Airport.

Existing tenants include Hollywood Bowl, Genting Casino, 11 screen Cineworld cinema, Five Guys, Zizzi, Nando's, GBK, Pizza Express, Miller & Carter and Las Iguanas.

New entrants to the scheme include Kaarage and the Hollywood Bowl has recently been upsized.

Unit FF02 is arranged across two floors, with 5,583 sq. ft on ground floor and 1,851 sq. ft at mezzanine level.

The unit is situated on the ground floor adjacent to Five Guys and nearby Zizzi, Las Iguanas and Miller and Carter.
