Location

Westbury-on-Trym is an affluent, principally residential suburb in north-west Bristol, popular with families and young professionals due to its local amenities and proximity to Bristol City Centre and Clifton Village. Westbury-on-Trym is easily accessible from Bristol City Centre and Clifton via Westbury Road (A4018), leading through the Clifton Downs from the top of Whiteladies Road. The A4018 also provides easy access to J17 of the M5, approximately 3 miles to the north.

The property occupies a prominent high street situation within Westbury-on-Trym, fronting directly onto the central round-about in the village centre. Nearby occupiers include Tesco Express, Loungers, Costa Coffee, a Co-Operative food store, banks, charity shops and as well as local and independent operators.

Description

The property comprises a mid-terrace, former bank arranged over ground and two upper floors. The property is of part stone, part brick construction beneath a pitched tiled roof. The ground floor front elevation is part glazed, part slate tiled, and the upper floors are a combination of exposed brickwork, and rendered and painted. To the rear, the ground floor extends to the adjoining car park boundary beneath a flat roof. It is located in the 'Westbury on Trym' conservation area.




