Description

A well appointed stylish 2 storey building with coated steel cladding in the Forest industrial park of Ketton. There is a shared personnel entrance to the front of the unit with stairs leading up to the first floor offices which range form 163 sq ft to 359 sq ft, each office is individually metered with aircon and heating. Shared toilets and a kitchenette are also positioned on the first floor.

Location

Ketton is a village in Rutland in the East Midlands of England. It is about 8 miles east of Oakham and 3 miles west of the centre of Stamford. The 2011 Census recorded a parish population of 1,926, making it the fourth largest settlement in Rutland, after Oakham, Uppingham and Cottesmore. The A1 is less than 2 miles away with North and South bound access.

Within the development there is a Private members Gym, a Prestige Car Dealer, a signage contractor and a range of smaller offices.




