27-31 Victoria Street is situated in the town centre, opposite Bachelors Acre, close to the Victoria Street multi-storey car park, William Street and Peascod Street retail leisure and banking facilities. The two main line stations are within easy walking distance, Windsor Central Station to London Paddington / Elizabeth Line via Slough (27 minutes fastest journey time) and The Windsor & Eton Riverside to Waterloo.

The M4 is close by at Junction 6 via Royal Windsor Way and the M25 Junction 13 approximately 6 miles, leading directly to Heathrow T5. Access from the Ascot direction is easy, via Windsor Great Park or via Winkfield past Legoland. The M3 Junction 3 is just beyond Ascot.
