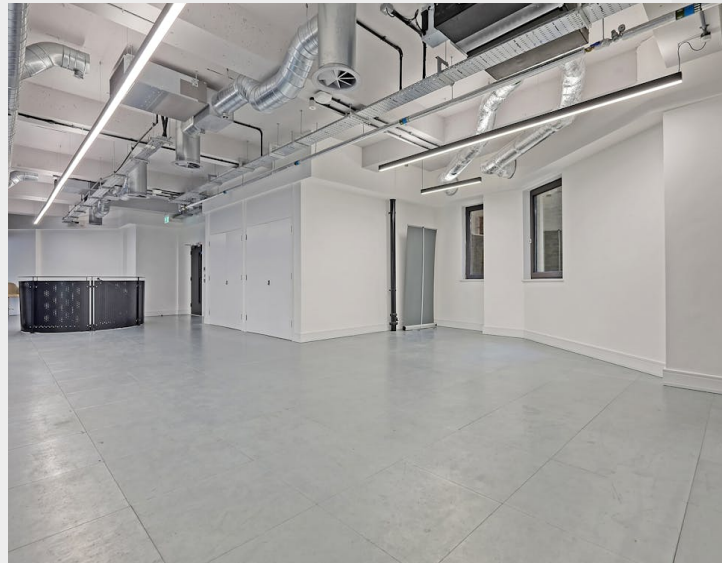

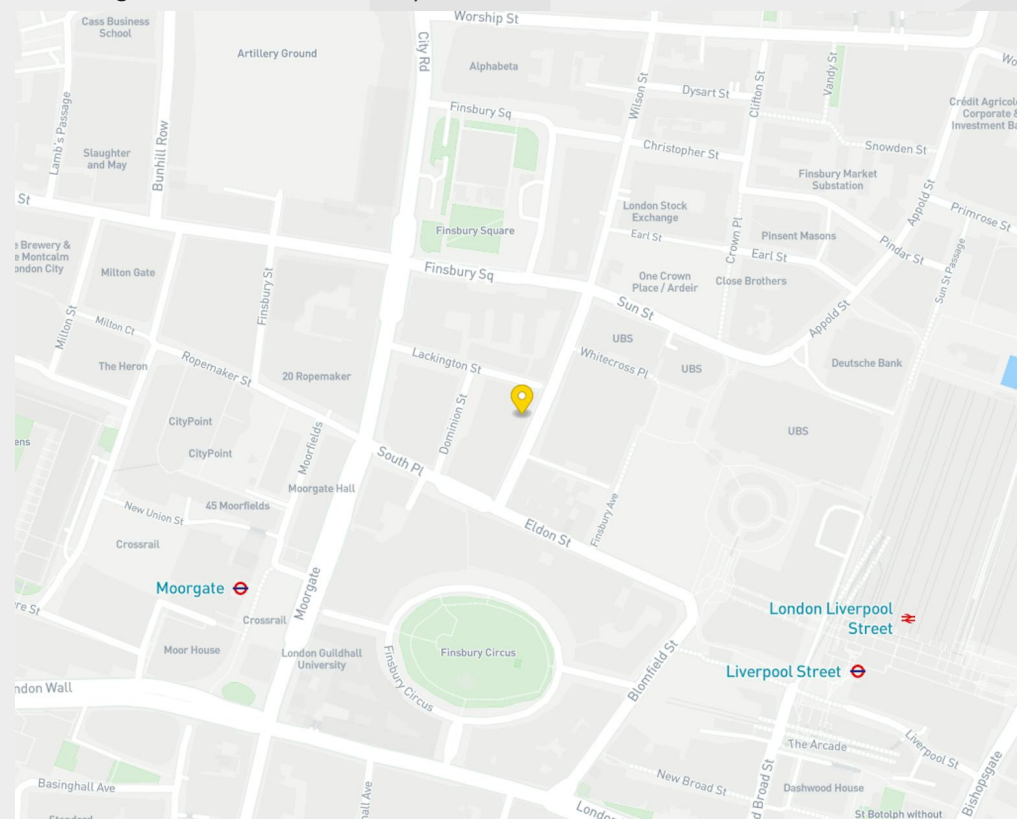


Description
