Location

The Property is located on Arrow Road North in Lakeside, with the surrounding properties being a mixture of Commercial and Residential Uses.

Redditch Town Centre is approximately $\frac{1}{2}$ mile to the west, with Junctions 2 and 3 of the M42 being within 10 minutes drive.

Description

The Property comprises a detached Warehouse/Workshop unit with adjacent single-storey Office accommodation, fronting onto Arrow Road North.

Internally, the Property is configured to provide Workshop/Treatment and Processing Bays, incorporating interceptor/recovery pits to part, with a number of roller shutter loading doors along the southern elevation. The eaves heights are generally circa 13' (4m), with a minimum working height of 10'2" (3.1m) This is supplemented with a mixture of cellular and open-plan Office accommodation, a Canteen and separate male and female WC's.

The Gross Internal Area (GIA) of the Property is approximately 12,419sqft (1,154sqm), with a section of Mezzanine Storage extending to approximately 297sqft (28sqm).

Externally, the Property is accessed via a tarmac surfaced Car Park to the front, which provides approximately 8 parking spaces with a substantial loading Yard to the side being a mixture of concrete, block paving and aggregate surface.

The Total Site Area extends to 0.8 acres (0.32 hectares).


