Location

Latham House boasts one of Birmingham's most premier office locations, conveniently located next to Birmingham Town Hall and Victoria Square. Latham House sits on the boundary of both the Birmingham business and the retail/leisure districts. Benefiting from excellent transport links. The Midland Metro Town Hall tram stop is on the doorstop of the building, with numerous arterial bus routes to and from the city also within close proximity. Situated within a 3 minute walk from New Street train station and just a 5 minute walk from both Moor Street and Snow Hill train stations.

Description

Latham House sits adjacent to the iconic Birmingham Town Hall and the new Paradise development. The building comprises nearly 24,000 sq ft of commercial accommodation arranged over basement, ground and six upper floors, with a typical floor plate of c. 4,000 sq ft.

Opportunity to lease a fully self-contained suite, with demised toilets. The current space is in need of full refurbishment, which the landlord is willing to undertake depending on lease terms. With access to the main reception/lobby area and lifts, there is also the option currently to take more space in the upper floors in the building. Viewing of the suite is highly recommended to fully appreciate the accommodation.
