Carmarthen is the county town and administrative centre of Carmarthenshire in South-West Wales. The town is located approximately 87 km (54 miles) north west of Cardiff, 48 km (30 miles) north west of Swansea.

The property occupies a corner position on the intersection of Mansel Street and Market Street. The indoor market is immediately to the East and St Catherine's Walk Shopping Centre is approximately 90 meters walk thereafter.
