Bethnal Green 0.1 Miles



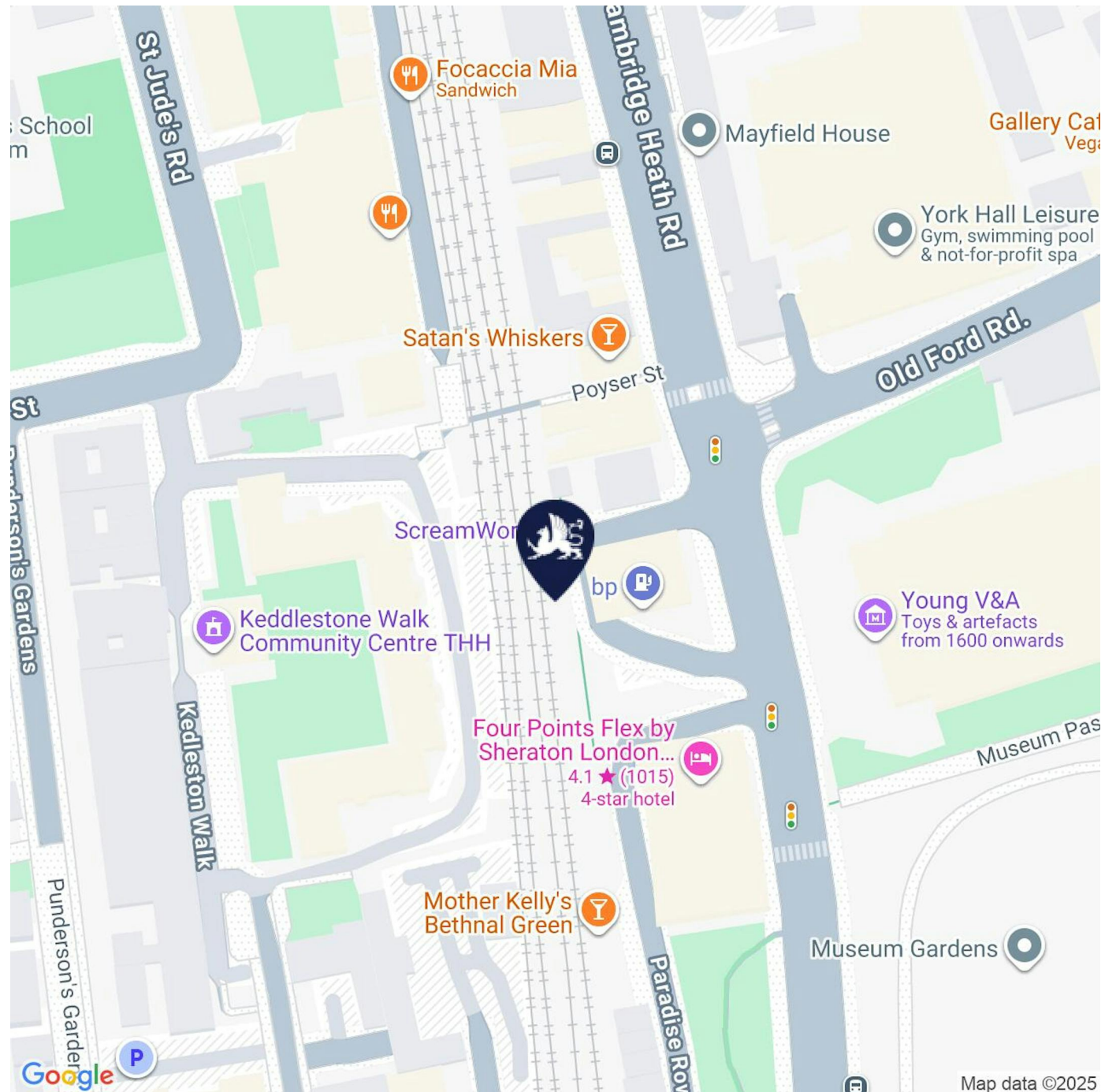
Cambridge Heath 0.2 Miles
