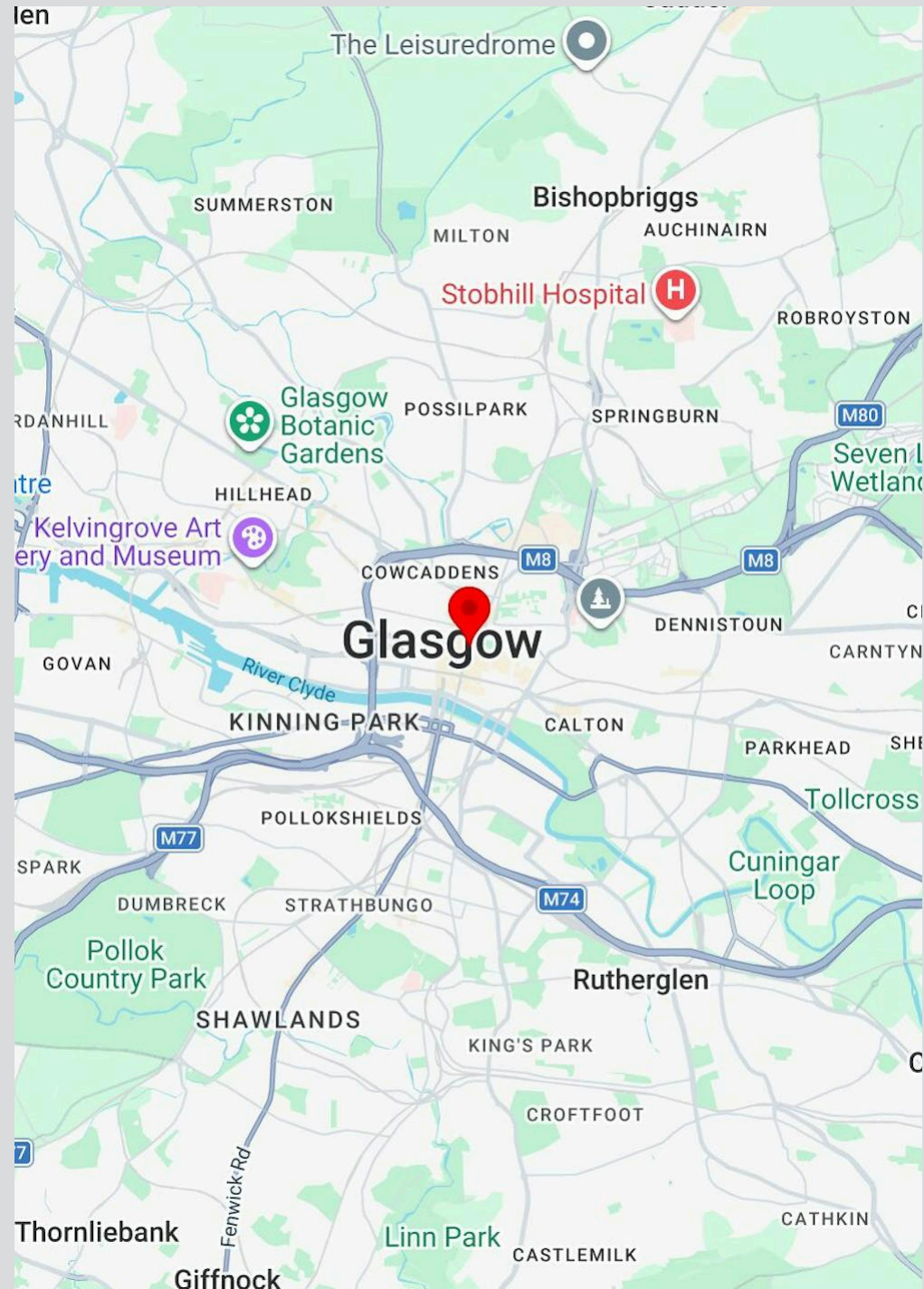

### LOCATION

The property is situated in the heart of Glasgow City Centre, within the Central Business District, occupying a prominent corner position at St Vincent Place and Buchanan Street, Scotland's busiest retail destinations. The surrounding area comprises a diverse mix of office and retail occupiers.

The property benefits from excellent transport connectivity, being located close to both Glasgow Queen Street and Glasgow Central Stations. In addition, Buchanan Street and St Enoch Subway Stations provide convenient local access across the city. There are multi story car parking available closeby, along with regular bus services. The M8, M74, and the wider motorway network are all readily accessible within a short drive.



## DESCRIPTION

The subject property comprises an office suite formed of three interconnecting suites, which can be occupied either separately or combined to provide a larger, single office space. The accommodation is situated on the third floor within St Vincent Chambers, a six-storey Category B listed building. The ground floor comprises a variety of high profile retail occupiers, including Ray-Ban, Breitling and TAG Heuer.

The building is of traditional red sandstone construction and is surmounted by a pitched roof. Access is provided via a secure, controlled entrance, with the building further benefiting from a passenger lift serving all floors.

The office accommodation benefits from excellent natural light throughout and includes kitchen and toilet facilities.

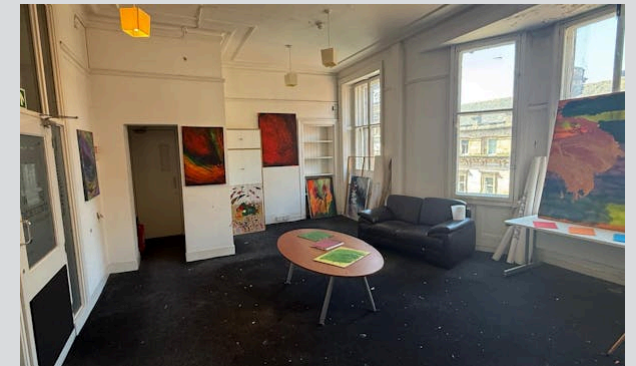
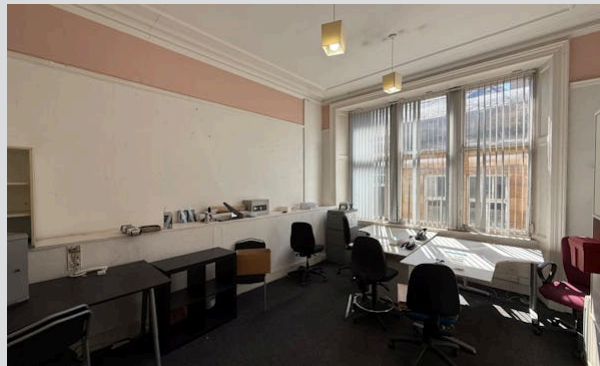

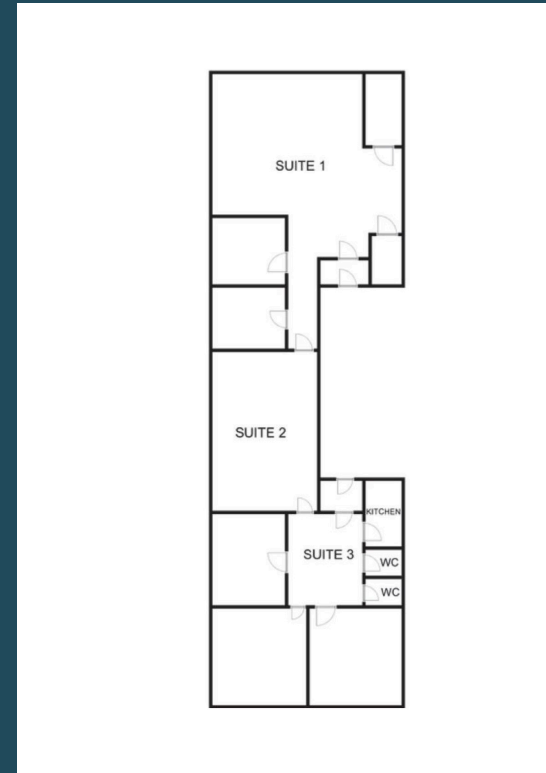
