## Description

An attractive corner retail premises benefiting from strong frontage and excellent visibility at the junction of Portland Road and Rutland Gardens, within a well-established Hove retail location.

The property comprises a self-contained ground floor retail unit with basement storage. The ground floor offers well-proportioned, open-plan sales space with good levels of natural light, suitable for a range of retail or service-based uses.

The basement offers useful storage and staff facilities, supporting day-to-day operational requirements. The unit further benefits from a small external display area fronting Rutland Gardens, providing additional scope for signage or product display and enhancing the overall prominence of the premises.

## Location

This property occupies a prominent corner position at the junction of Portland Road and Rutland Gardens within an established retail parade in Hove. Portland Road forms part of a well-regarded local commercial pitch serving a densely populated residential area, benefiting from strong levels of passing pedestrian and vehicular traffic throughout the day.

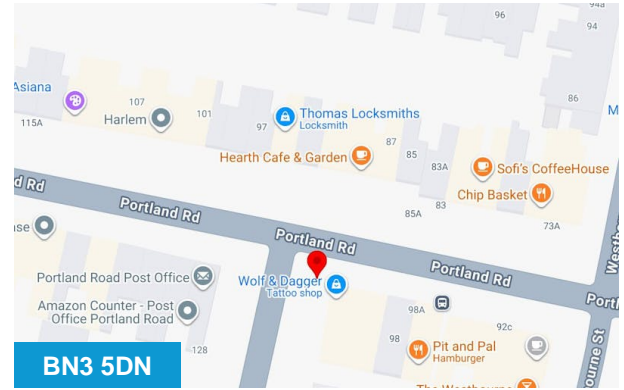
The surrounding area comprises a strong mix of independent and regional retailers, such as The Flour Pot Bakery, Body Base, Brass Monkeys and Costa Coffee, creating an active and established retail environment. The unit is well placed to serve the surrounding residential population, which provides a consistent and reliable customer base for day-to-day retail trade.

The location is well connected, with Church Road (A259) providing a direct route into central Brighton to the east and towards Hove and Shoreham-by-Sea to the west. Public transport links are readily available nearby, with regular bus services operating along Portland Road and surrounding routes, while Hove railway station is within walking distance, offering direct services to London and along the south coast.
