Description

Unit 1D is constructed with a steel portal frame and concrete floor, finished with profiled metal cladding. Vehicular access is provided via two roller shutter doors (one at surface level and one at dock level) with a separate pedestrian entrance. The unit benefits from a 3-phase power supply.

Internally, the property provides warehouse/workshop accommodation with welfare facilities, and office space. The unit also benefits from roof light panels providing natural lighting throughout.

Location

Pitreavie Business Park, Dunfermline is Fife's leading business and industrial estate, located within easy reach of the M90 motorway. The Forth Road Bridge and Edinburgh are easily accessible to the south (4 miles and 15 miles respectively).

Excellent distributor road access is provided via Pitreavie Way from the main dual carriageway, Queensferry Road, which connects directly to the M90.
