LOCATION

Wessex Trade Centre is a leading industrial location having access from both Old Wareham Rd and Ringwood Road. Poole Town Centre is approx. 3 miles to the south-west.

The central location gives good access within and beyond the Poole/Bournemouth conurbation. Ringwood Road links with the A31 and onto the motorway network. Old Wareham Road provides direct links with A3049 dual carriage way.

DESCRIPTION

The property is prominently located with visibility from Old Wareham Road. The property is configured to provide ground floor open plan storage/workshop with male and female WC's, an office/reception and kitchen (to be installed) with open plan office above.
