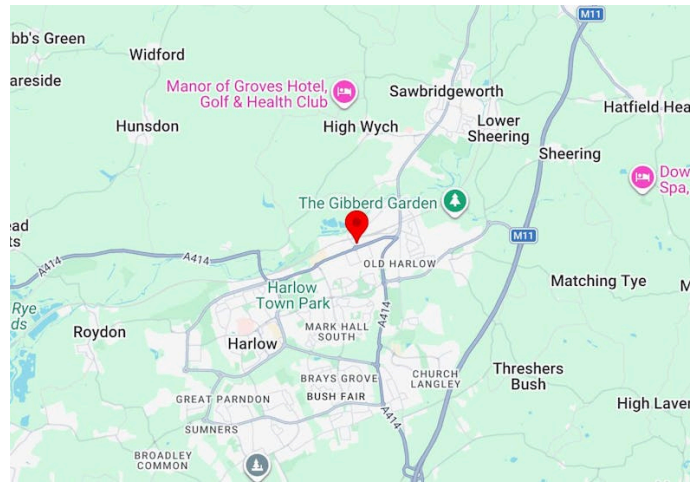

## Description

The property comprises a level and surfaced yard with part frontage on to Riverway and just set back from Edinburgh Way, the main arterial route through Harlow.

Services including 3 phase power, mains drainage and water connections are to be provided and the landlord can provide porta cabin office with WC if required.

## Location

The Property is located close to the junction of Edinburgh Way with Riverway.

Its immediate neighbours include Screwix, Nicholls & Clarke, Magnet Kitchens, Euro Car Parts, Bristol Street Motors Peugeot and Marshalls Volkswagen.

Most national trade counter operators are within close proximity to the Property, and the most out-of-town retailers are located on the various retail parks that front Edinburgh Way.

The Property is within easy walking distance of Harlow Mill station serving London Liverpool Street via Tottenham Hale (Victoria Line).

Harlow is situated to the East of the M11 and Junction 7 (c4 miles) and 7a is (c3 miles) from the Property.

Harlow is an expanding new town with a current population of c90,500. This is due to increase within major housing developments planned for the area.
