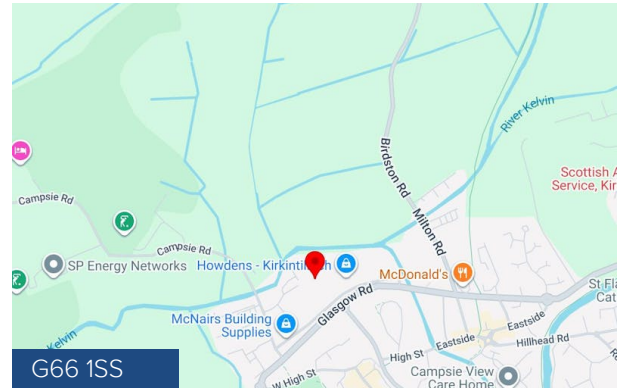

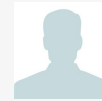

LOCATION

Kirkintilloch is located around 12 miles north of Glasgow and sits within the East Dunbartonshire Council area. The Town is principally accessed via the A803 which connects with the M80 motorway via neighbouring Bishopbriggs. A wide range of services and facilities are available within the town with good transport links to/from Glasgow city centre via both road and rail.

The property is located within the popular and well established Old Mill Park Industrial Estate which lies to the north of the Kirkintilloch Town Centre, adjacent to Glasgow Road (A803). Surrounding occupiers within the estate include Direct Flooring, Saltire Carpets & Beds, McNairs Building Supplies and Kirkintilloch Self-Storage.

PROPERTY

The property comprises a mid-terrace brick built unit forming part of a larger block which was historically subdivided and has roof structures of northlight construction.

The property benefits from full height vehicle access roller shutter and separate pedestrian access

The property is over ground and first floors connected by two stairways, one to the front and one to the rear. The property is protected by security roller shutters. The ground floor has showroom / workshop / storage space.

The upper floor has been renovated to a good standard offering open plan office and tea prep with partitioned rear office / store and w.c facilities.
