Description

The property comprises a mid-terraced warehouse / business unit forming part of a wider, well-maintained estate. Internally, the unit comprises ground floor storage / production areas, small entrance lobby, welfare facilities and kitchenette. The first floor is accessed via an internal staircase leading to a substantial, first floor mezzanine providing a mix of cellular offices and open plan offices / production areas.
