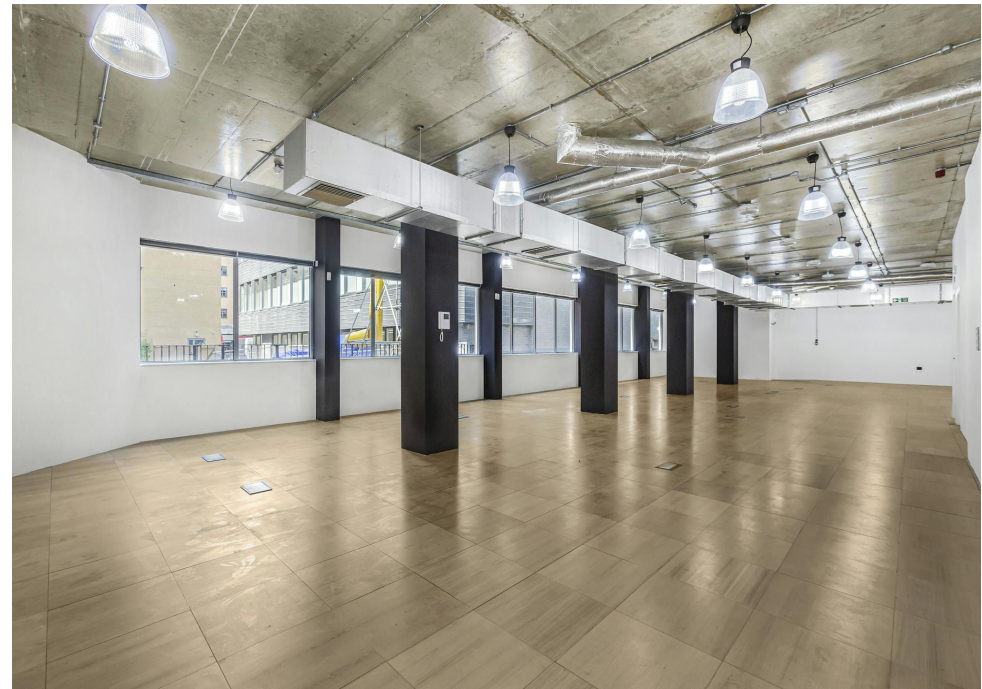
Fully cabled and fitted with a boardroom, meeting room and directors office, the space offers an opportunity for an occupier to move straight in.

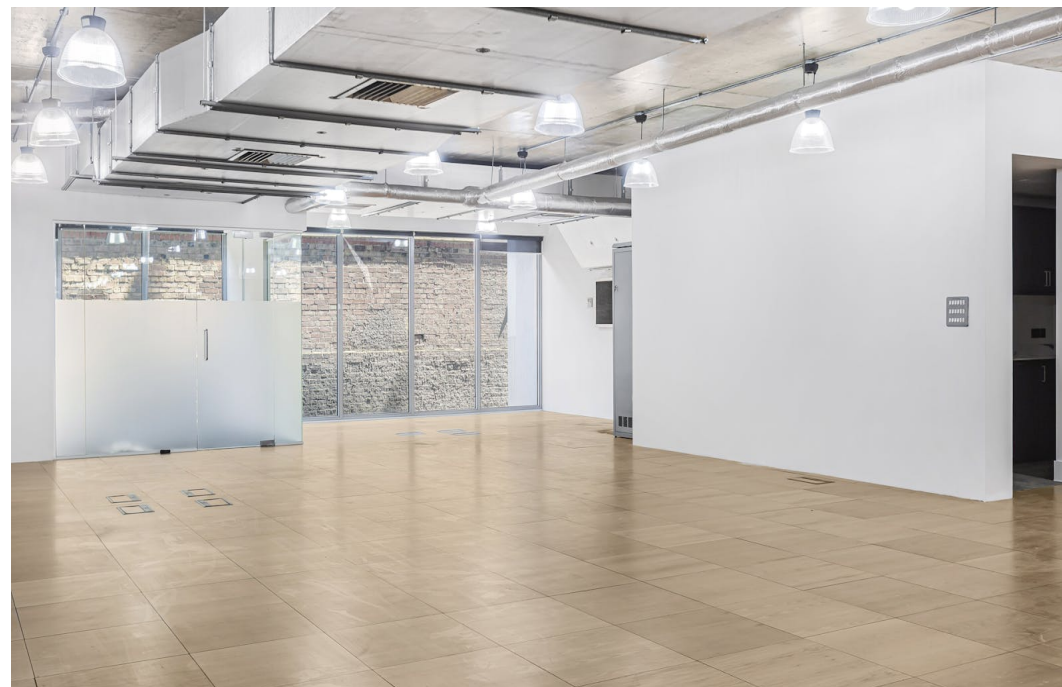
Location
