#### Description

The property comprises a detached industrial unit of part brick and clad elevations under a pitched roof. Its configuration consists of a warehouse with offices fronting Molly Millars Lane. The warehouse benefits from a dedicated loading yard and two loading doors accessible via a covered loading area. The offices present well with a suspending ceilings, LED lighting and comfort cooling/heating provision. Additionally, the premises benefits from a separate parking area to the West Elevation.

#### Location

Molly Millars Business Centre is situated on the south side of Molly Millars Lane and is accessed via the A321 (Finchampstead Road). It is located approximately 3 miles from the A329(M), providing links to Reading (9 miles east) and Junction 10 of the M4 Motorway. Wokingham Train Station is located 1.5 miles away, providing railway services to Reading and London Waterloo.
