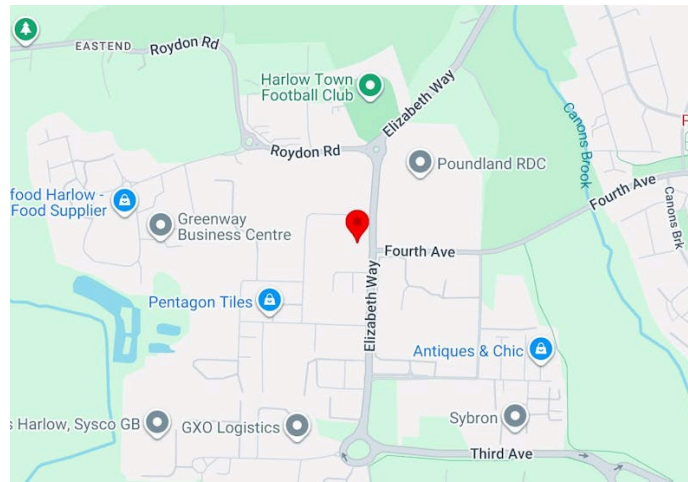

Description

Kenrich Business Park comprises 15 refurbished units of varying sizes on a secure gated site. Unit 1 is an end-terraced unit of steel frame construction with steel clad elevations under a 'North Light' roof. Internally the unit principally comprises clear span industrial/warehouse floor space with an accessible W.C and Tea-point. The unit is lit via LED warehouse lighting.

Location

The Property is located prominently on Elizabeth Way (A1169) within the Pinnacles industrial/commercial area of Harlow. The area is a short distance from the A414 which connects with the A10 to the West and the M11 to the East at Junction 7. The M11 thereafter links with the M25 approximately 5.5 miles to the South. Harlow town train station is approximately 1.



6 miles away which serve both Cambridge and London Liverpool Street, via Tottenham Hale (Victoria Line) Amenities close by include a petrol station, restaurant and bakers.
