

Further Details

Description

This mid-terrace premises is arranged as a two-storey business premises with fully fitted offices at first floor and part storage and part offices on the ground floor. The premises is of blockwork inner, brick work outer construction with steel cladding to the upper elevations and the pitched roof. There are windows at ground and first floor levels in the front elevation. A roller shutter door provides loading access to the storage area, measuring approx. 3m W x 2.1m H. The offices benefit from suspended ceiling, lighting, carpets, air conditioning, and electric heating. The first floor offices are arranged as predominantly open plan with a board room and 3 separate offices. There are kitchenette and W.C facilities. 3 phase electricity and gas are available. Externally, there is a tarmacadam forecourt providing loading access and car parking for approx. 10 cars when double parked.
