LOCATION

The property is situated on the purpose-built Uddens Industrial Trading Estate which is located adjacent to the established Ferndown Industrial Estate, approximately 2 miles from Wimborne Town Centre.

Road connections locally are afforded with close links to the A31 which serves Bournemouth and Poole, as well as the southern motorway network.

DESCRIPTION

The property comprises a mixed-terrace industrial unit constructed of steel portal frame, with cavity brick and block walls supporting a pitched corrugated sheeted roof with translucent panels.
