The property is prominently located in Ludlow town centre fronting onto The Bullring. The Bullring serves as one of the prime retail streets in the retail hierarchy of Ludlow. The surroundings occupiers include Oxfam, Nationwide, Robin Let Shoes and C W Sellors. The property is located within close proximity of the junction of The Bullring with Corve Street and King Street.

Ludlow is a market town and civil parish in Shropshire, England. It is located 28 miles (45 km) south of Shrewsbury and 23 miles (37 km) north of Hereford, on the A49 road which bypasses the town. The town is near the confluence of the rivers Corve and Teme.

Ludlow has nearly 500 listed buildings, including examples of medieval and Tudor-style half-timbered buildings. The town was described by Sir John Betjeman as "probably the loveliest town in England".

The property is understood to form part of a property that is Grade 2 listed.


