Description

The dual aspect property comprises a self-contained ground floor retail unit being prominently positioned to face both Victoria Square and Commercial Way. Internally, the premises provides a mainly open-plan sales area which boasts floor to ceiling windows and ancillary accommodation towards the rear.

Commercial Way forms one of the principal shopping streets for the town and links directly with Victoria Place, Wolsey Place and The Peacocks shopping centre, together with a range of national multiple and independent retailers, cafés and restaurants. Woking mainline railway station is within a short walking distance, providing regular services to London Waterloo, and there are several multi-storey and surface car parks nearby, affording convenient access by public and private transport.

Location

The premises are located in the heart of Woking town centre, directly adjacent to Victoria Square and within a few minutes' walk of Woking station. Woking is a highly connected commuter town, offering direct rail services to London Waterloo in approximately 20 minutes. The town also benefits from excellent road communications, with close proximity to the M25 and A3, providing access to the wider Surrey area and beyond.







