10G Samson Close is situated within the well-established George Stephenson Industrial Estate in Killingworth — a highly accessible commercial hub in the North East.

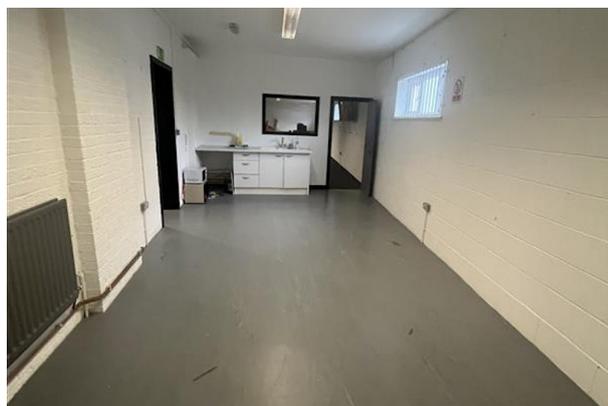
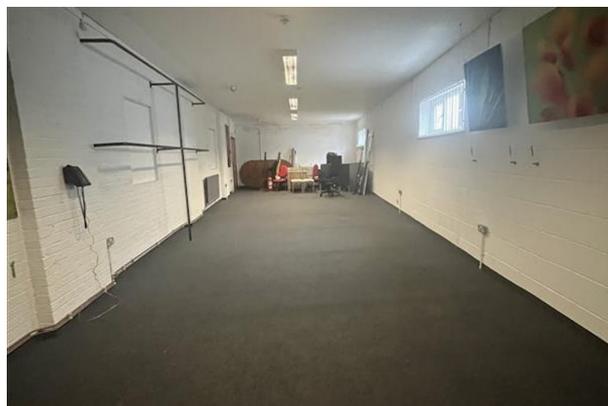
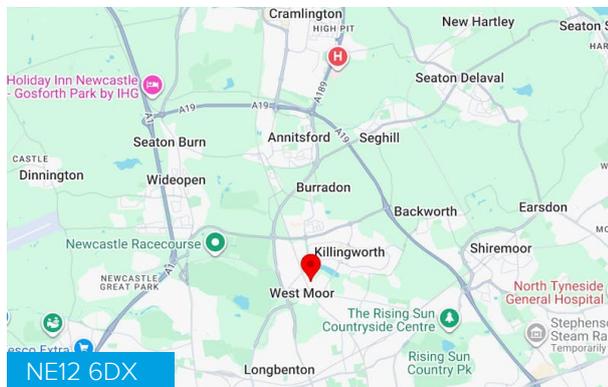
