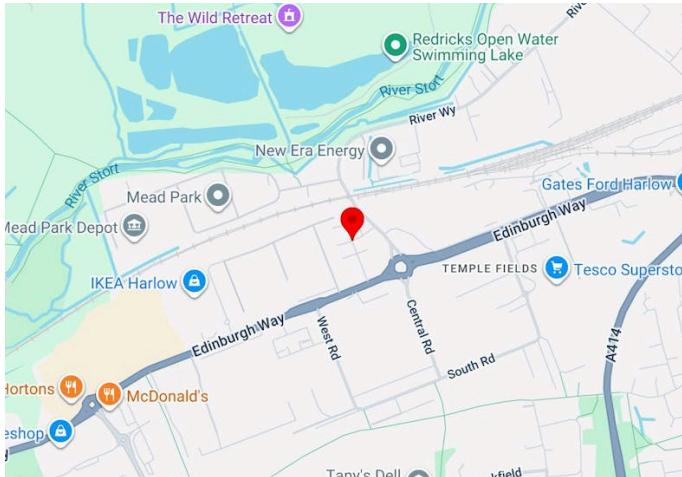

Description

Stephen Taylor House comprises a detached two storey purpose built medical building suitable for a variety of uses including offices. The property is mainly of brick clad elevations incorporating extensive double glazing to the front and rear all under a pitched and ridged roof.

Internally the accommodation provides a mix of offices, treatment rooms and staff welfare facilities. There are male and female W/Cs to each floor and a further accessible W/C at ground floor.

Externally there is a detached garage/storage building. A tarmacadam forecourt provides space for 13 cars.

Location

The property is situated in Edinburgh Place just off Edinburgh Way close to the junction with River Way.



Edinburgh Way is the main out of town retail, motor trade and trade counter location within Harlow. A number of food and beverage offers including Greggs and Costa are within easy walking distance of the premises.

Harlow Mill railway station serving London's Liverpool Street (via Tottenham Hale) to the south and Stansted International Airport and Cambridge to the north is within walking distance. Road links are excellent. The recently opened Junction 7a serving the M11 and Cambridge to the North and intersecting to the M25 approximately 8 miles to the south.

Harlow itself is an expanding town with a resident population of approximately 93,000.
