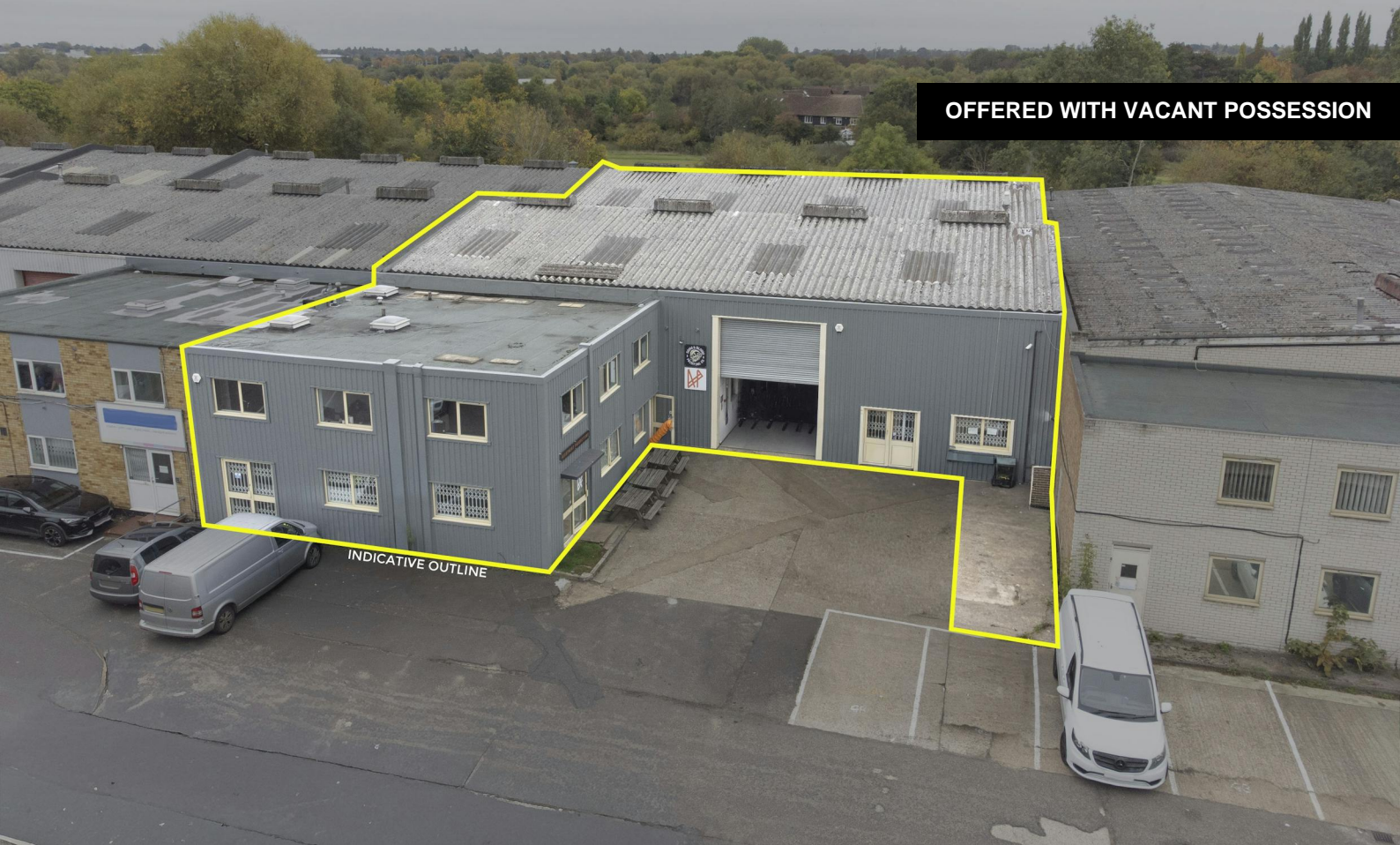

Location

The premises are situated on Paddock Road in the Lower Caversham area, just northwest of Reading centre. Both Reading central and Reading Central railway station are easily accessible providing regular high-speed services to London via the Elizabeth Line, including the surrounding regions and Crossrail. Description

Unit 4A Paddock Road comprises a mid terraced industrial / warehouse unit with a double pitched roof. Clear open plan warehousing is arranged over the ground floor and ancillary office accommodation is available to the first floor level. 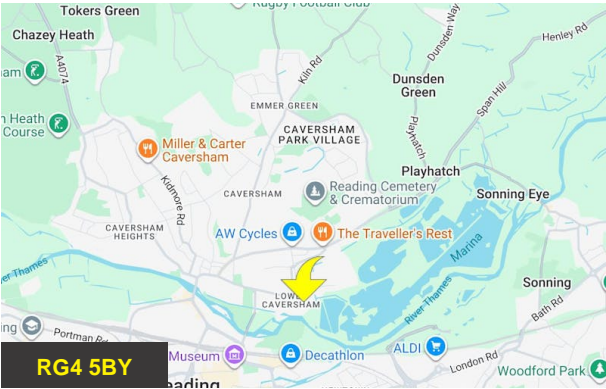
