Ample car parking is available in the vicinity.

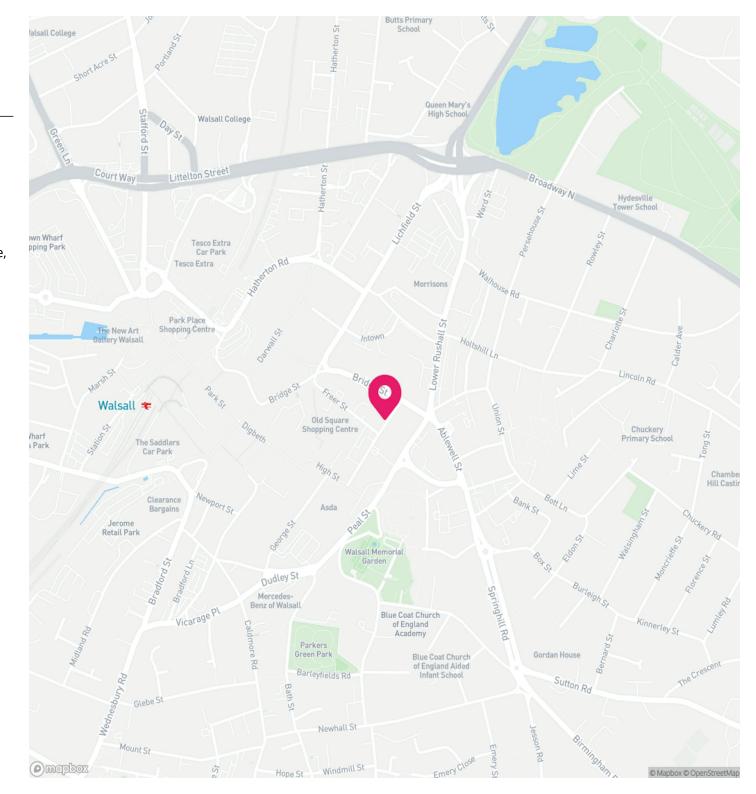






LOCATION
