Old Street 0.3 Miles



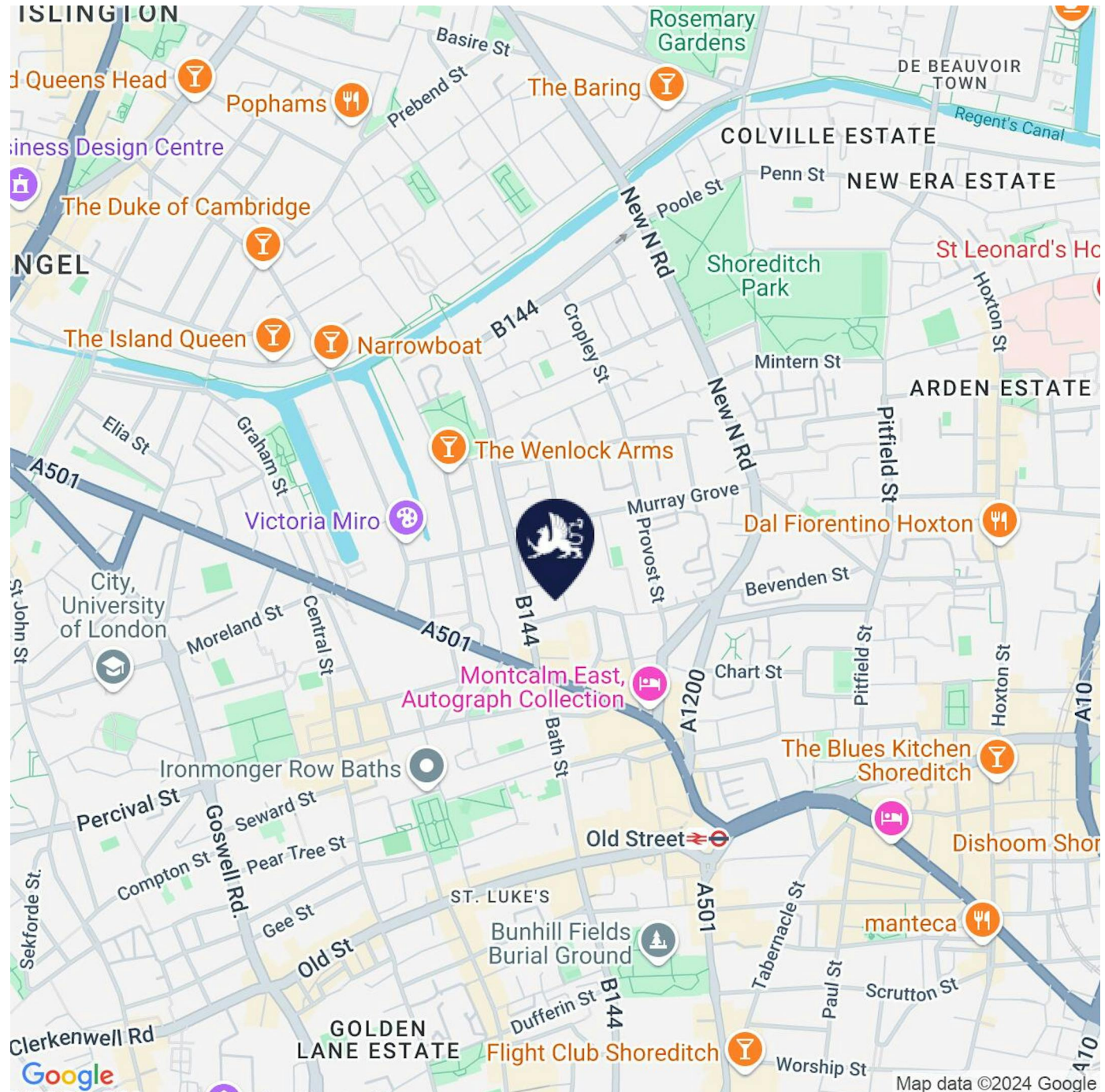
Angel 0.7 Miles

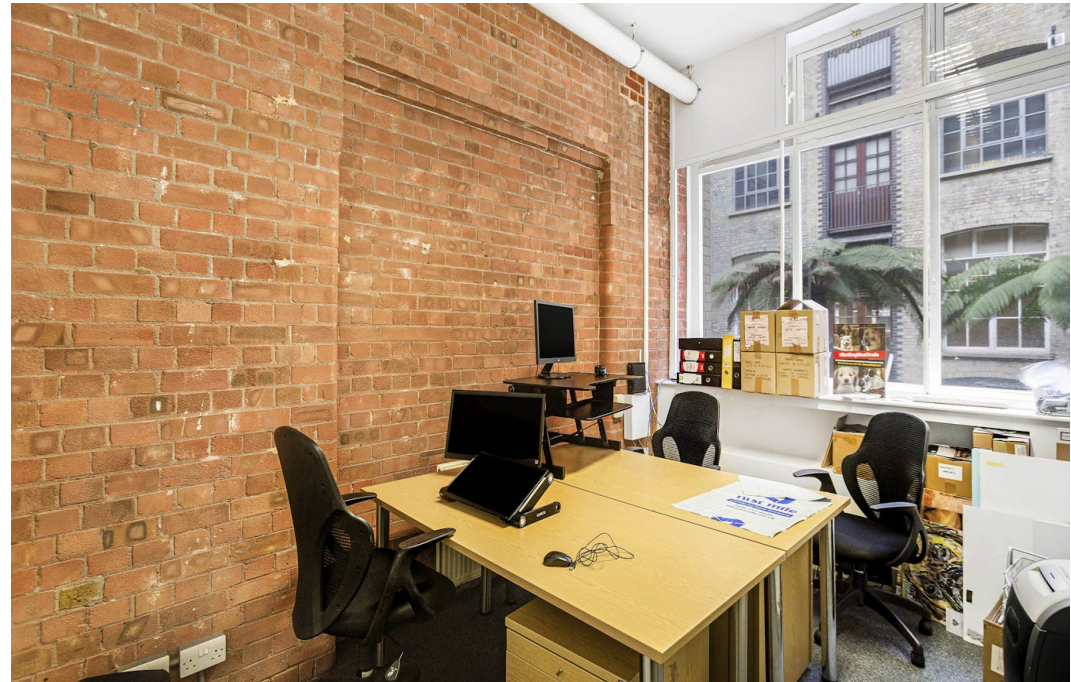


Hoxton 0.7 Miles
