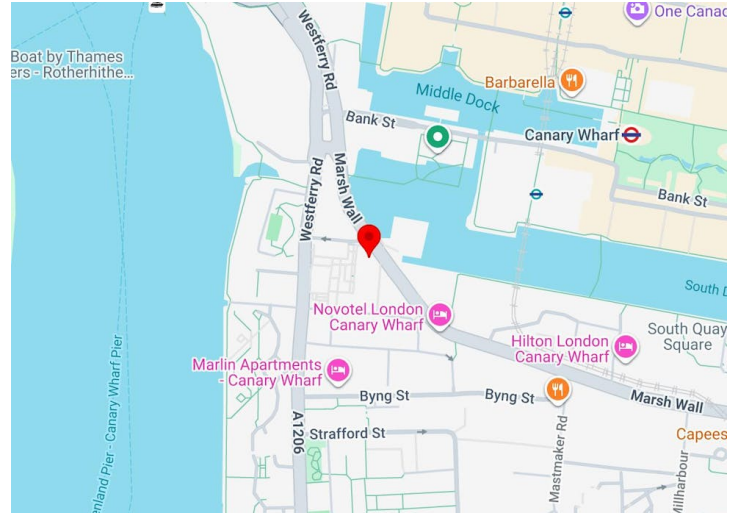

Description

Landmark Square is a mixed-use development designed by Squire and Partners. The development consists of over 700 residential units with ground floor commercial occupied by Tesco metro and a Bright Horizons nursery.

The available unit occupies a prominent position along Marsh Wall and is arranged over basement, ground and first floors. The unit benefits being triple aspect, predominantly west facing and is fully glazed.

The ground and first floors are currently fitted-out as offices including plasterboard suspended ceiling with integrated lighting, underfloor trunking and air-conditioning.

The ground floor has a floor height of 3.3 metres and first floor 2.9 metres.

The basement is a clean dry area accessed via a dedicated lift from the upper floors or via the estate underground car-park. This area has a head height of 2 metres.

There are two underground staff parking spaces.

Location

Landmark Square is located at South Quay, and is within a 2 minute walk from the Canary Wharf estate.

The property has a prominent ground floor location along the main arterial road of Marsh Wall.

Train connections are at Canary Wharf for the Jubilee and Elizabeth Lines and Heron Quay/South Quay for the DLR.

The Canary Wharf area is now an established, vibrant working and living environment. The area currently comprises c.20 million sq. ft. of offices and over 200 shops, restaurants and bars accommodating over 120,000 workers.

The Canary Wharf estate continues to expand closer to the Landmark Square property evidenced at Bank Street along Heron Quay with tenants Soc Gen and the European Bank whilst JP Morgan are planning their 3 Millions sq.ft HQ close to the property at Riverside.

In addition to the success of the office expansion in the area there have been numerous high-rise residential schemes similar to the development at Landmark Square that is a compliment to the offices and leisure occupiers in the area that has created a day and night time working and living environment.
