Yeomans Industrial Park is located on Yeomans Way which is to the rear of Castlepoint Shopping Centre. It is accessed from Yeomans Way Roundabout off Castle Lane West which provides direct access to the A338 Wessex Way, connecting with the A31.

Further Details

Description

This end of terrace unit is of blockwork inner, brickwork outer wall construction with steel cladding to the upper elevations. There is a pitched steel clad roof incorporating daylight panels supported upon a steel portal frame and the internal eaves height is approximately 4m. Loading is by way of a roller shutter door measuring approx. 3m W x 3.6m H. There is a personnel door and W.C facilities. 3 phase electricity is available.

Externally, there is a tarmacadam forecourt providing 2 allocated car parking spaces and a loading area.



