

DESCRIPTION

Chertsey Business Park offers modern and flexible warehouse units suitable for a wide range of industrial uses, as supported by B1 (c), B2 and B8 planning consent. Units 3-4 are combined to provide 8,170 sq ft GIA, with an option to split to suit individual requirements. Unit 3 extends to 4,015 sq ft GIA and Unit 4 extends to 4,155 sq ft GIA. The property benefits from LED lighting, 3 phase power supply and 2x electric roller shutter doors. There is a clear internal eaves height of 8.4m across both units as well as WC facilities. In total there are 9 demised car parking spaces, including a vehicle turning circle positioned immediately opposite Unit 4. The site itself is secure and situated within a landscaped environment. The scheme was designed with several green initiatives, including electric vehicle charging points, secure cycle parking and high performance insulated cladding and roof materials.

LOCATION

Chertsey is located within the south west of the M25 with excellent transport links to main arterial roads. Chertsey Business Park is situated on Hanworth Lane, within the most centrally located industrial area in Chertsey. The property is within walking distance to the high street and railway station.
