Pinnacle 2 is a landmark office building located in Dublin's Docklands. #### Location

East Point Business Park benefits from a convenient location adjacent to the Port tunnel, with Dublin Airport only a 15 minute journey.

The business park is well served by public transport and occupiers have access to a shuttle bus to nearby DART and Clontarf, The Luas at the Point Square and The Docklands Rail Station.

The park benefits from on-site amenities including a weekly market, physio, crèche, communal bicycle facilities (Moby Electric bikes), dry cleaners, 5-a-side football pitches and tennis courts.
