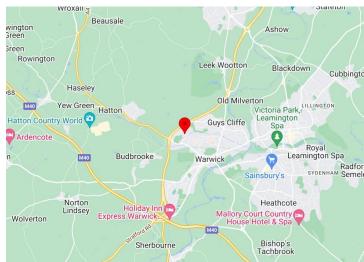

Location

The property is located in Broxell Close, close to its junction with Wedgnock Lane, approximately one mile northwest of Warwick town centre. Parkway One benefits from excellent road communications and is in close proximity to the A46 and about 2 miles to the north of J15 of the M40. Warwick Parkway station is 1 mile from the property and has direct links to Birmingham New Street and Snow Hill stations and London Marylebone

Description

The Parkway development was constructed in 2004 and comprises two buildings set within a landscaped environment. The subject premises is a two-storey and self-contained property, and is of steel frame construction with brick, block-work and glazed elevations beneath a pitched plastic-coated insulated profile steel clad roof.

The property has been completed to a good standard with specification including raised floors, suspended ceilings incorporating recessed lighting, heating/air cooling system, carpeting, intruder alarm, fire alarm and door entry system. There is a kitchen area with fitted cupboards, tiled walls and vinyl floor covering on both the ground and first floors. Toilet facilities are provided on both floors with the disabled toilet facilities on the ground floor. Externally there is a landscaped environment and surfaced parking for 10 cars.
