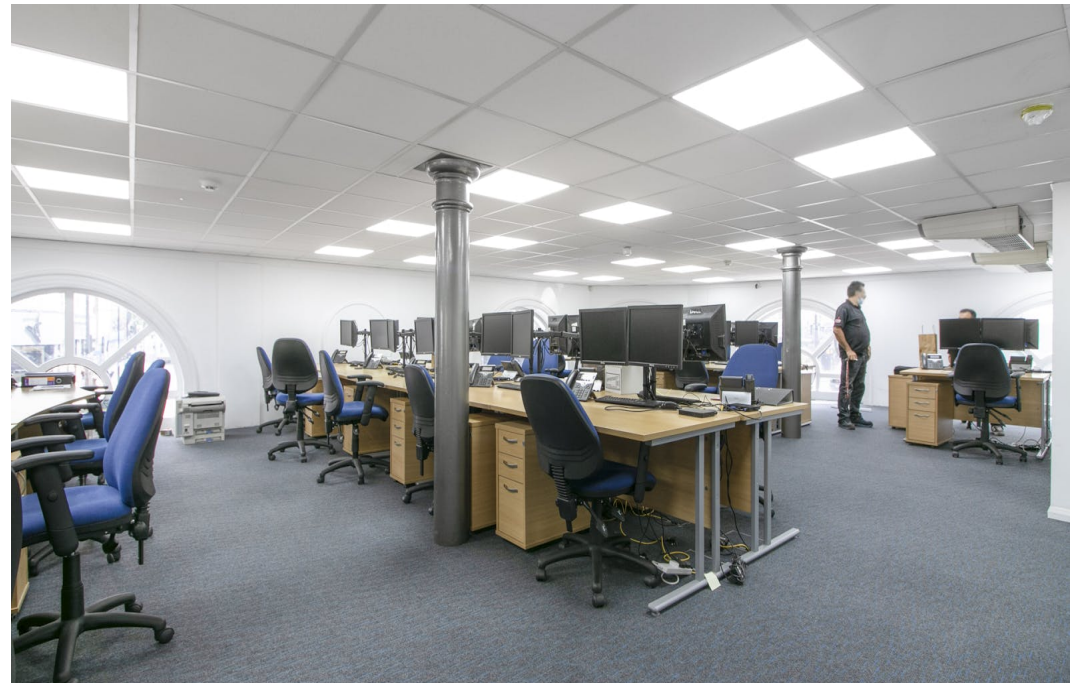
The property is situated in a prime corner position in the heart of Dalston Town Centre, yards away from Dalston Junction Station.

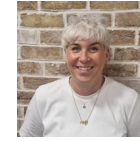
