Location

The property is situated on Beoley Road West, in the well-established residential and commercial area of Redditch. The location benefits from good local amenities and transport connections, with Redditch Town Centre and Train Station within close proximity. The property also offers convenient access to the A435 and wider motorway network via the M42 (Junction 3).

Description

The opportunity comprises a substantial mixed-use property with adjoining residential accommodation as follows:

86 - 88 Beoley Road West comprises a ground floor fast-food takeaway arranged as fully fitted Sales Area including frying range; Food Preparation; further food prep and stores. The total GIA of the commercial area is 1315sqft. A Ground floor lobby provides access to the first floor flat comprising 4 bedrooms and a bathroom.

82 Beoley Road West forms a two-bedroom end-terrace house, interlinked with No. 86-88, arranged as a Living Room; Utility; Bathroom and Two Bedrooms.

The properties occupy a site extending to 0.128 acres, benefiting from a double garage, secure parking, and garden space. The interconnecting nature of the buildings makes them well suited to sale as a whole, offering flexibility for an investor, owner-occupier or redevelopment potential (subject to planning).
