# Location

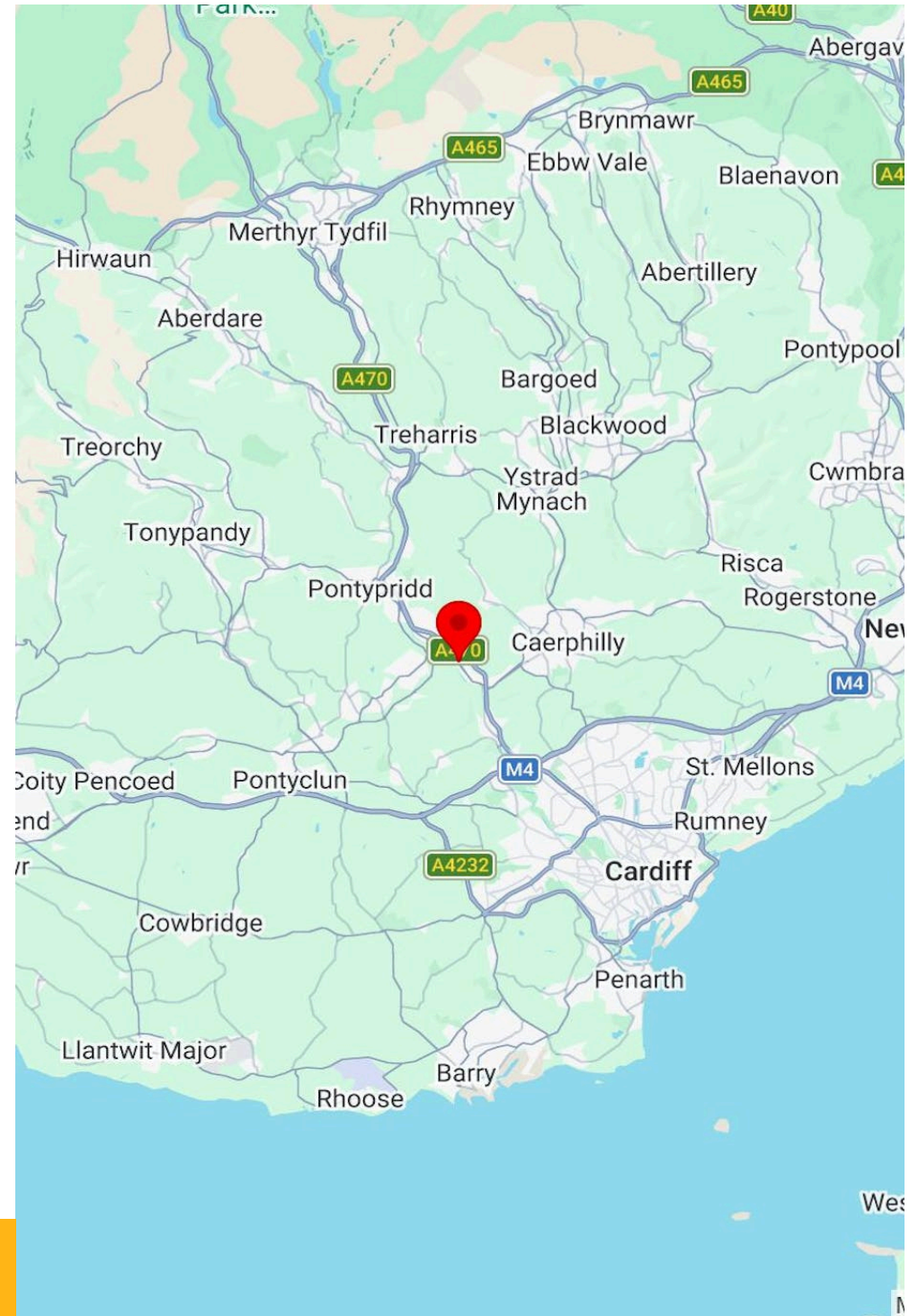

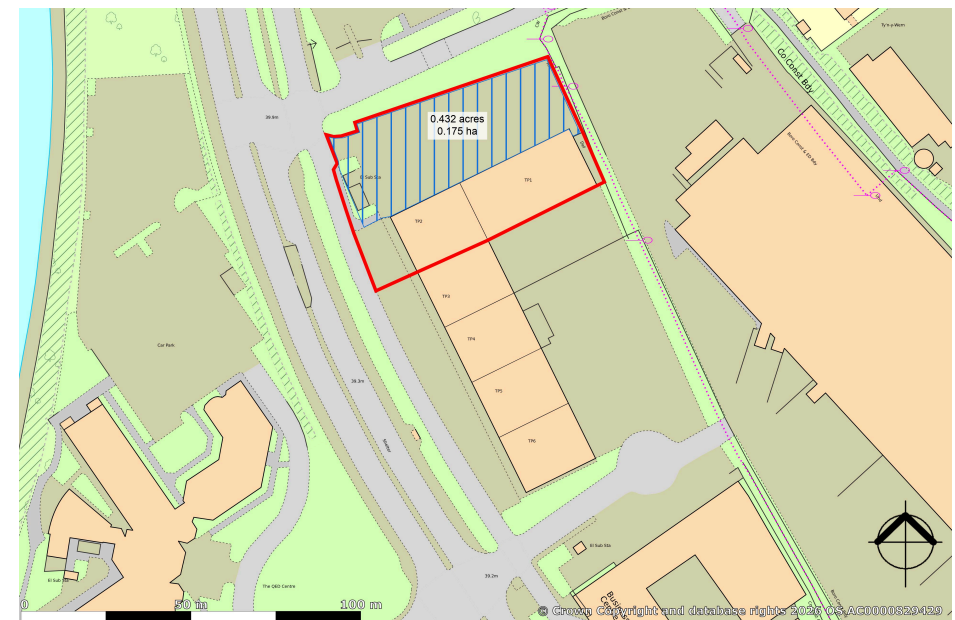
