Description

The property comprises a self contained retail unit with first floor offices to the front and rear plus mezzanine store/sales area in the righthand retail bay.

Planning permission was granted for a change of use from warehouse to retail, B1/B8 and office use, in 1990 (planning reference WA/1990/0875). We therefore believe that the building now benefits from the new Class E planning. Formerly the property was used as a retail unit selling musical instruments and a store/office.

Location

Haslemere is an affluent town located close to the Surrey/Hampshire/Sussex border with excellent access to the A3. Haslemere also has a mainline railway station with average journey times to London Waterloo of 50 minutes.

Wey Hill itself is an established retail destination approximately 1 mile from Haslemere town centre and occupiers in the immediate vicinity include Majestic Wine, Tesco, Co-op Food and an M&S Foodhall.


