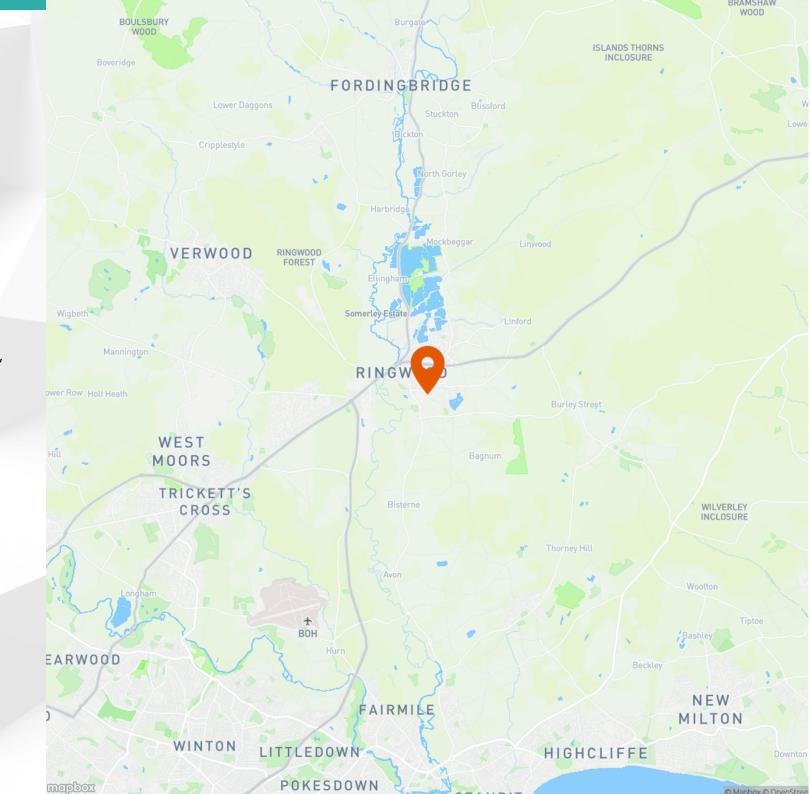


Location

Way. It is approximately 1 mile distant

restaurant facilities. Access to the A31 is
approx. 1 mile distant from the premises,
which provides direct links to the
M27/M3 motorway networks.

Description

Crow House is a business premises providing warehouse/industrial space with fitted office accommodation. The premises comprises a two-storey brick building to the front of the premises with a steel-clad warehouse to the rear. The two-storey section provides office accommodation, and the current occupier is using the ground floor area as part of their warehouse production area, but this can be returned to office accommodation. The building benefits from the following specification:

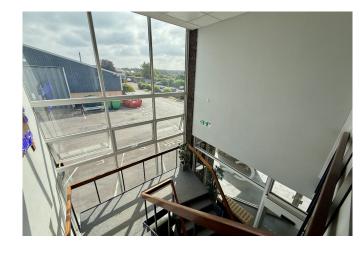








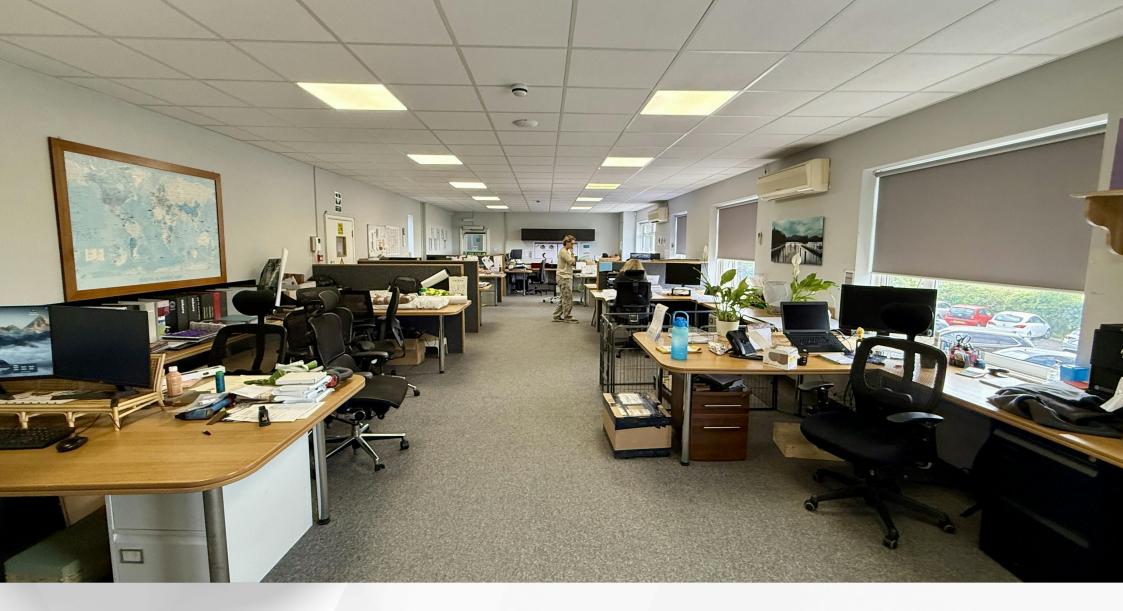
