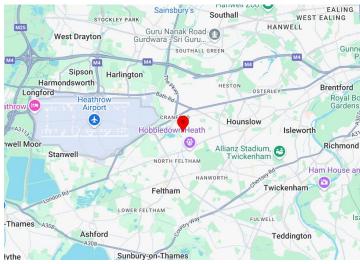

Description

Unit 5 comprises a detached stand alone unit on one of Heathrow's greenest industrial parks, built with sustainability in mind and is net carbon zero in use. The unit is of steel portal frame construction providing clear span space with ancillary first floor Grade A offices with associated reception, WC & showers. The warehouse benefits from 8m eaves, LED lighting throughout, 2 electric level access loading doors and 37.5 kN/sq m floor loading.

Location

Communication Park is within close proximity to Heathrow Airport and Cargo Terminal. The scheme fronts Green Lane which is accessed off the A312 and A315. The M3 and M4 motorways are with 4 miles. Feltham and Hounslow Town Centres are both within easy reach. Feltham railway is approximately 1.5 miles, Hatton Cross and Hounslow West (both Piccadilly) underground stations are within two miles.
