Description

The premises fronts a period style Grade II Listed premises known as 4 The Quadrant which fronts Warwick Road. Externally there is a parking area in front of the building serving the buildings on the parade. Internally the building is accessed via a main entrance which leads to a reception area with further walk ways leading to a mixture of cellular offices located on the ground, first and second floor areas. Stairwells provide access to these areas. A stairwell also leads to the buildings basement area which is currently used for file storage.

At the rear and accessible via a separate entrance or via 4 The Quadrant, is the area known as Manor Court which provides ground, first and in part second floor offices. The offices on the ground and first floor level are divided into separate rooms approached from a central corridor. These offices have been recently refurbished in part and benefit from LED lighting, new carpet tiled flooring, ample electrical sockets and gas central heating. There are communal WC facilities available on the ground floor and first floor.

Location

The premises/site is situated on the southern side of Coventry City Centre off Warwick Road, located close to the City Centre Ring Road, with ease of access throughout the city and wider region. The property is also within a short walk of Coventry's main railway station, the Friargate Development and the proposed City Centre South Development.

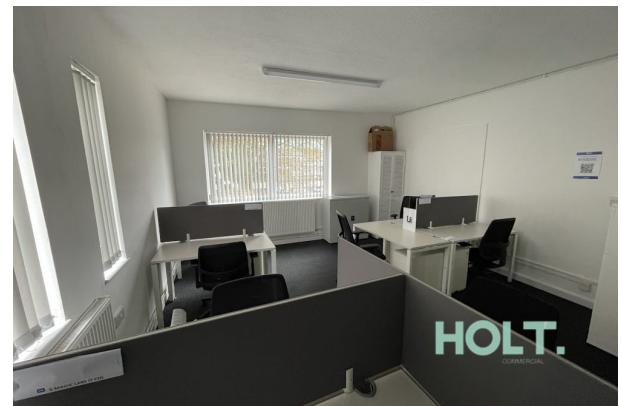
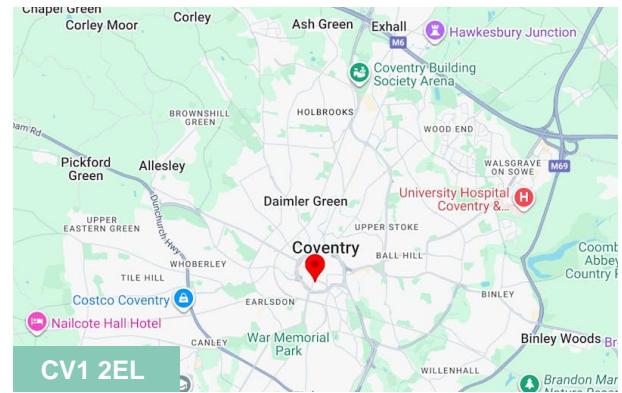

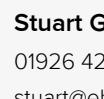
