Tringham House occupies a prominent corner position fronting Castle Lane East and Deansleigh Road. It forms part of the Wessex Fields development situated opposite Bournemouth Hospital. The property benefits from excellent access to the A338 Wessex Way, which is approx. half a mile distant, providing excellent access to the main road network across the conurbation.

The property is located opposite Bournemouth Hospital bus station, which is serviced by M1, 22, 24, 33, 14, 15, X1, X2, X3 and X6 routes. In the nearby vicinity, there is a Costa Coffee, Co-Op, Tesco, The Village Hotel & Gym and Starbucks providing amenities for employees.

Description

Tringham House is a 4-storey office building providing impressive Grade A office accommodation with excellent car parking provision. There is a barrier entry car park and landscaped grounds externally, which lead to an impressive communal reception area. There are communal W.C and shower facilities. The ground floor is currently arranged as predominantly open plan with a partitioned board room and 2 partitioned offices. The accommodation benefits from the following brief specification:

- Suspended ceilings
- LED lighting
- Carpets
- Air conditioning

Externally, there are EV charging points and bicycle storage. There are 40 allocated car parking spaces which provides an excellent car parking ratio of approx. 1 space per 190 sq ft. Additionally, there are shared visitors parking spaces.
