Description

Ground floor and basement lock up shop, which was occupied until recently by a Caribbean restaurant t/a 'Flayvas', is now offered with vacant possession and is set up and ready for immediate occupation offering a true turn key opportunity.

The premises currently provides an open plan main shop/serving area to the ground floor, with kitchen/backroom off, and internal stairs leading to the basement where a storage area and W/C are located. There is also a generous enclosed decked outside seating area to the front and side of the building.

Location

The property is well located on the corner of Upper Chorlton Road and Shrewsbury Street, close to the junction of Withington Road and Chorlton Road and sits on the border of Old Trafford and Whalley Range in the Metropolitan Borough of Trafford.

The immediate area benefits from excellent transport links, being within the 'Bee Network' of bus routes which provides easy access to Manchester City centre and the surrounding areas. The property is also almost equidistant to both Firwood Metrolink and Trafford Bar Metrolink Stations, with both being around a 12 minute walk.
